***Directives to the authors***

**1. In the text**

- Please accentuate capitals (e.g. État instead of Etat)
- Citations in an ancient language (Latin, medieval French, etc.) : in italics, without inverted commas.
- Citations in a modern language : in roman letters, with inverted commas ("").
- Footnotes have to be placed before the punctuation (, - . - ? etc.).
- Try to avoid, as much as possible, the use of numbered subdivisions in your text (1.2.1 or I A1, etc.).
- Please write dates in full (e.g.: 29 May 1933, and not 29-05-1933 or 29. v. 1933, etc.).
- Try to avoid the use of bold characters (except for indicating the subdivisions of your text) and of capitals (except for bibliographic references in footnotes: name of the authors have to be set in capitals).
- Use capital letters for every word in names of institutions and journals. E.g.: *International Review of Social History*; International Monetary Fund. Every meaningful word of the titles of books in English are put in capitals; in other languages, use small letters.

**2. In the Footnotes**

- The first name of authors has to be written in full when used for the first time.
- Please use small caps for names of authors (Jean STENGERS), when using Roman figures (Pope John XXXIII, Elisabeth II, etc.) and for abbreviations of institutions (NA, PRO, UNO, etc.).
- Please use the following system :

- Titles of periodicals, names of institutions, etc. may be abbreviated if they are used more than once, on the condition that the abbreviation is explicitly mentioned the first time.

- Please don't use the parenthetical in-text reference system, and avoid references such as (CONSTANTINE 1980)

- When referring to a previously cited publication, please note the name of the author (in capitals) and an abbreviation of the title before using the words *op. cit.* or *loc. cit.* <optional : you can mention the number of the footnote where the reference is given in full>.

- Dates are written in full, even in the footnotes.

- The list of abbreviations (for journals, institutions, etc.) has to be placed in front of the text (in footnote 1 or \*).

- If you are referring to the edition of an ancient or medieval author, please mention the name of the editor, as well as the date of the edition.

### ***3. Abstract***

- Please write an abstract (of about ten lines) of your article, both in English, in French and in Dutch. The title of your contribution also has to be translated. Mention a few key-words.
